

# ONLINE PRIVACY POLICY AGREEMENT

Crowley, LLC () values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Crowley, LLC of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

## **Why We Collect Information and For How Long**

We are collecting your data for several reasons:

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

### **Use of Information Collected**

Crowley, LLC may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request.
